- 1. The tasks described in this worksheet are part of the formative assessment. They serve the purpose to prepare you for the examination. We will discuss the solutions during the next **interactive session** after they are handed out while they fit to the lecture of the week they are handed out, they might be discussed in two weeks time due to the bi-weekly exercise schedule.
- 2. Make sure to plan your time for the whole sheet carefully. The complete exercise should represent approximately three hours of independent study. Task 1: Understanding the NetCDF Data Modell (90 min)

As part of this exercise, you will inspect NetCDF data and visualize it. Then, you will create a data model and a corresponding NetCDF file from it.

Follow these steps for the inspection:

- Download the NetCDF file: https://www.unidata.ucar.edu/software/netcdf/examples/ECMWF_ERA-40_subset.nc
- Inspect the header first and then the data using ncdump
- Visualize the variables using ncview

Create a CDL data model for the following use case:

- wikipediaWC should be an array of word counts for 10 specific words
- population should be a 3D array of the number of people on the world surface over time
- populationCity should be a 2D array of the number of people living in cities over time

Create a corresponding CDL file with some sample data and autogenerate the NetCDF file.

Hints

- You may need to install additional packages on your system to add ncdump and ncview such as netcdf-bin and ncview.
- Use ncgen3 to create the model
- With ncdump, a corresponding ASCII file in CDL can be created from a NetCDF file
- With ncgen3 <INPUT> -o <OUT>, the NetCDF file can be created again

Task 2: Creating you Own Benchmark using the Scientific Method (150 min)

In the lecture, you saw the importance of benchmarks to assess system performance. As part of this task, you'll create a simple benchmark (in the programming language of your choice) for measuring I/O performance and assess its outcome.

The recommendation for the approach is as follows:

- 1. First, think about the pattern you like to measure, e.g., sequential I/O of 100 KiB accesses.
- 2. Define the measurement protocol and metrics: How to time the operations, granularity of the measurement. How do you increase confidence that the returned value reflects the true value in the system?
- 3. Think about the expected performance on your system and document it.
- 4. Implement the benchmark.
- 5. Run the benchmark in such a way that it meets your experiment's measurement protocol.
- 6. Compare the results with your observations and document them briefly.
- 7. Conclude the experiment in your measurement protocol. Compare your steps and methodology with the scientific method.
