Citation — placement & style

- Present sources for your claims
- Use cite command and manage sources as biblatex file
- Sources should directly follow respective claim
 - ▶ The performance of the system under study was found to be close to native performance leading to the conclusion that it is suitable for HPC usage. **[REF]**
 - ▶ The performance of the system under study was found to be close to native performance **[REF]** leading to the conclusion that it is suitable for HPC usage.
- Sources and authors can also be directly referenced
 - ▶ Author et al. **[REF1]** found a new method for compressing textual data, which complements the protocol presented in **[REF2]** allowing for more stable and efficient data transfer.

Types of citation

■ Paraphrased / indirect (default in technical writing)

- ▶ Rephrase in your own words and cite the source. **[REF]**
- ▶ Example (narrative): Author shows that the proposed scheduler reduces average latency by 23%. **[REF]**
- ▶ Example (parenthetical): The scheduler reduces average latency by 23%. **[REF]**

■ Direct / literal (use sparingly)

- ▶ Quote only when wording carries special meaning (definitions, exact claims).
- ▶ Example (short): “Direct citations are placed in quotation marks.” **[REF, p. 17]**
- ▶ Example (long): For 2+ lines, set as a block quote in your text editor or thesis template. **[REF, pp. 17–18]**

In-text patterns & secondary sources

■ Author patterns

- ▶ One author: Author **[REF]**
- ▶ Two authors: Author and Coauthor **[REF]**
- ▶ Three–five authors: list all on first mention; then use “et al.” **[REF]**
- ▶ Six or more authors: use “et al.” from the first mention **[REF]**
- ▶ Same author and year: disambiguate with a/b/c (e.g., 2015a, 2015b). **[REF]**

■ Secondary source (last resort)

- ▶ If the original is unavailable: “Author (original) as cited in Other Author (year).” **[REF]**

■ Figures and tables

- ▶ Direct reproduction: exact copy, cite the source. **[REF]**
- ▶ Indirect reproduction: adapted/modified version, cite as adapted. **[REF]**

Internet sources & reference list

■ Internet sources

- ▶ Treat like other sources in-text. **[REF]**
- ▶ In the reference list, provide the exact URL; include DOI when available. **[REF]**
- ▶ Avoid “Retrieved from” unless the page content changes frequently. **[REF]**

■ Reference list

- ▶ Alphabetical by author, then chronologically. **[REF]**
- ▶ Use one consistent style across all entries. **[REF]**
- ▶ Include page numbers for direct quotations. **[REF]**

■ Common pitfalls to avoid

- ▶ Late or ambiguous citation placement
- ▶ Overuse of long quotations
- ▶ Missing attribution in figure/table captions
